2. To enter, customers must spend \$10 or more at any Specialty Store in one (1) transaction on any one (1) day within the period of the competition.
3. Entry Forms may be filled out by customers of Griffith Central who have met the minimum spend conditions.
4. Entries can be submitted online via the website, QR Code in-Centre or via the official competition posts on the Griffith Central social media page. A valid Tax Receipt must be uploaded to form a valid entry.
5. Entries may also be submitted via a printed Entry Form available at participating Retailers. Any printed Entry Form must be the original. Photocopies, scanned images, reproductions or altered Entry Forms will not be accepted.
